"Donations to the Endowment fund are simple. You can merely designate a donation to the fund by simply stating so, which restricts where that donation goes. If you let us know you want it to go there, then that's where we will place the donation. The goal here is to have enough in the fund to produce an income to support our programs. Our initial investment of just over \$50K will accrue income each month. It will take a while to grow, but with everyone's support we are sure we can make that goal. Donators can even specifically bequeath an endowment fund donation from their will as a long-lasting legacy of their commitment to the Center and to the local Hill Country programs we provide."
